Thank you for your information request indicated in bold below, which has now been considered under the Freedom of Information Act 2000 by NHS Cheshire & Merseyside Integrated Care Board (ICB). I am able to provide you with the following information and responses.

Please note from 01 July 2022, Clinical Commissioning Groups (CCGs) were disestablished, and their statutory functions and responsibilities inherited by NHS Cheshire and Merseyside ICB.

**1) Under freedom of Information can you send a copy of the building surveyors report**

**Our Response:**

1) Please find enclosed a copy of the '*Park View Health Centre Survey of Existing Building*' held by NHS Cheshire & Merseyside ICB and which was commissioned by the former NHS Liverpool CCG.

Upon review of the enclosed document NHS Cheshire & Merseyside ICB has redacted information identifying and relating to individual people, which are considered to constitute 'personal information' under the Data Protection Act and, as a result, are exempt from disclosure under section 40(2) of the Freedom of Information Act 2000.

**2) Under FOI can you give indicative figures for patients being relocated to which alternative surgeries**

**Our Response:**

2) Please be advised that NHS Cheshire & Merseyside ICB is in the process of working on the reallocation of patients registered with Park View Health Centre. As a result, we are currently unable to provide figures for Park View Health Centre patients being reallocated to alternative surgeries until this piece of work has been finalised and agreed.
