Thank you for your information request indicated in bold below, which has now been considered under the Freedom of Information Act 2000 by NHS Cheshire & Merseyside Integrated Care Board (ICB). I am able to provide you with the following information and responses.

Please note from 01 July 2022, Clinical Commissioning Groups (CCGs) were disestablished, and their statutory functions and responsibilities inherited by NHS Cheshire and Merseyside ICB.

Your Request:

- 1) How many patient transport journeys were booked for discharging patients in 2021/22?
- 2) What was the total cost of these journeys?
- 3) How many of these journeys were 'out of hours' and to non-contract providers? And how much did these cost?
- 4) How do the hospitals book transportation for discharging patients? Is there an IT system?

Our Response:

1 - 4) NHS Cheshire & Merseyside ICB does not hold information specifically detailing how many patient transport journeys were booked for discharging patients, the total cost of the journeys, whether the journeys were out of hours or the hospital booking systems used for transportation of patients being discharged.
